Methodology

- Set up Compliance and/or RC Plan By selecting relevant topics from the customisable knowledge database
- Define Compliance and/or RC Missions

 - Document the evidence of controls
 - Link the controls to the risks identified
 - Rank your recommendations
 - Escalate your recommendations to relevant stakeholders


