LPEA'S REACTION TO COVID

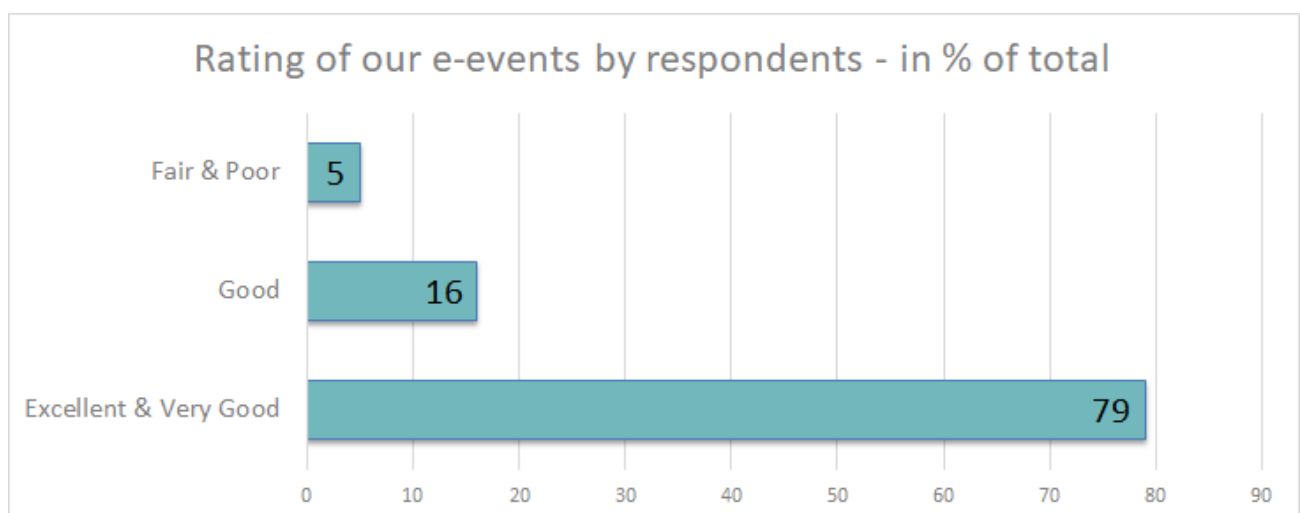
